INTRODUCTION

Zamiya Rawzatul Uloom Society has been formed by a group of like-minded people committed to education, and it was founded on August 8, 2013. Our NGO activities majorly work on education and are determined to help the hopeless by reshaping otherwise collapsing society. With a variety of relief programs organized for the poor children, women, elderly, and physically disadvantaged, the future seems bright. Zamiya Rawzatul Uloom Society Has Specialized in the capacity of the building of grass-roots organizations, The modern education system, free education, skill training, and material development. Society was formally registered during the year 2013 register under the Act 2012. The member of the society largely consists of volunteers who are professionals, in Agriculturist, Medical, Business, and social worker awareness program activists. Society has been active in Umra Area. Zamiya Rawzatul Uloom Society is helping the poor with education and help from social activity and funding all poor, disabled people and students in Haryana state.

Our organization's major focus is on improving the educational system, and our Zamiya Rawzatul-Uloom society running a school in Umra village called Flah-E-Insaniyat Public School, where we teach classes I to V and is located on a crossroads linking various areas of the community. As a result, the student will be able to attend school without difficulties. The schoolhouse is a large structure with several components that are still being built. There are several rooms in this school, and presently about more than 600 children read here. The classrooms are large and well-equipped, with all of the necessary amenities and furnishings, as well as a decent playground. In our school, there are 10 instructors. The supervisor is a wise and experienced guy. The other teachers are likewise well-versed in the subject.

In Umra village, our organization also operates a School for females, which teaches various languages such as Hindi, English, Urdu, and Arabic for a low fee of only 5000 rupees per year. We also want to create a stay-and-learn program for girls and boys beginning next year, which will include free meals, free school attendance, and separate

female teachers dedicated to girls' contemporary education. Apart from that, the society runs another school for males, which provides free food and accommodation and charges just Rs 2000 per year. In 5 acres, Zamiya Rawzatul-Uloom will be the sole institute for males, particularly orphans. There is no other institute of this sort in Nuh that offers modern education as well as a place to stay. Our main aim is to provide education to every child.

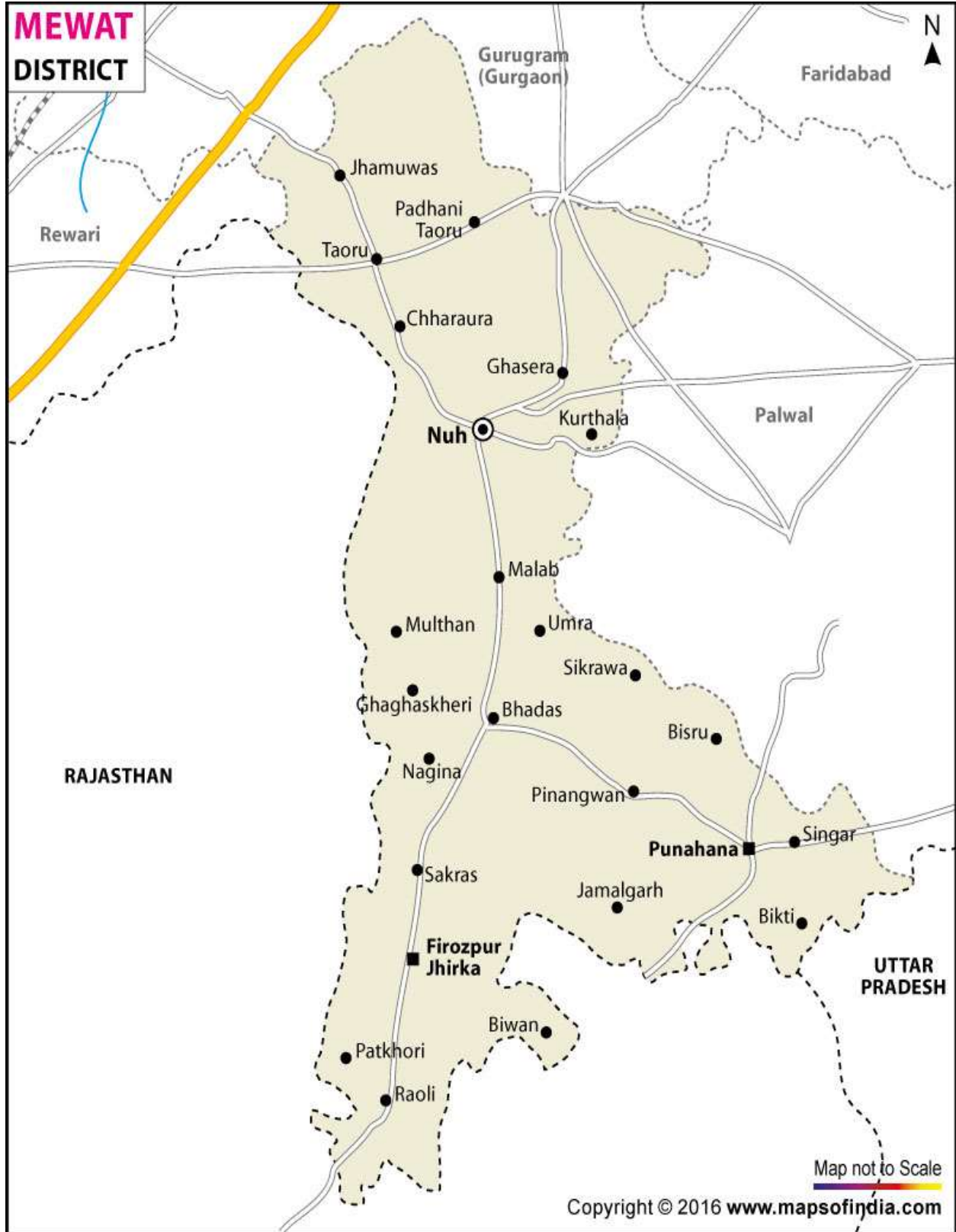
Zamiya Rawzatul-Uloom society has to impart many kinds of learning to women and Children and Especially Blind Students like the learning of concepts, rules, principles, aesthetic discrimination, etc., through problem-solving and other skills. Inherent to the acquisition of these Kinds of learning is the development of the right attitude and values.

It is important to realize that values can't be entirely taught as a subject in school and the inculcation of values can do it be left only to the moral science or value education teacher. Every teacher of this society is equally responsible for this undertaking inside and outside the classrooms, for value education.

There are many procedures & influences through which a child forms its attitude and values. The school & teacher is certainly one of the most important of these influences and it's worthwhile to find out how a school can most effectively carry out this duty.

In the year, various Educational Program for beneficiaries was organized. Resource persons were present for giving information to beneficiaries in the program. More than 300 beneficiaries attended the program. Besides, we educated them on various issues.

MAJOR PROBLEMS OF THE AREA RELATING TO PROJECT

The most developed and urbanised state in India is Haryana. The old Mewat district was renamed Nuh district, one of the 22 districts that make up the Indian state of Haryana. The four subdivisions of this district are Nuh, Ferozpur Jhirka, Punahana, and Taoru. It is 1,860 square kilometres (720 square miles) in size, and 1.09 million people called it home in 2011. Its northern boundary is formed by the Gurugram District, its eastern border by the Palwal District of Haryana, and its southern and western borders by the Alwar District of Rajasthan. It borders the Rajasthani districts of Bharatpur and Mathura as well as the Bichhor and Nai Villages of the Punhana Tehsil. The bulk of the Meo ethnic group's population are farmers.

2018 saw the former Mewat district ranked as the most undeveloped of India's 739 districts by the country's top policy think tank, Niti Aayog. This district has the lowest health and nutrition, education, agricultural and water resources, financial inclusion and skill development, and basic infrastructure while neighboring Gurgaon District, Haryana's wealthy industrial and financial hub.

Apart from that **Major Problem in the area are as follows:**

1. Higher rate of Unemployment
2. Lack of Higher Education.
3. Subsistence Based economic activity,
4. Lack of education facility.

PROJECT IMPORTANCE

90% of the population of the huge District of Nuh (Mewat) is Muslim. There are no factories, jobs, or businesses here. Mewat is also significantly behind in the field of education, and there is no large hospital in the region where people might receive the greatest care.

The whole Mewat region lacks any type of University, large or small. Even though there is a water deficit, we have only set up around 40 tube wells. A stream requires even more tube wells than we now have. For the built-up area of 3000 sqft, the total construction area for the ground floor (including parking) amounts to roughly Rs 20.00 Lakhs. The organisation estimates that a donation of Rs 20 lakhs will provide them a significant boost

in ramping up the remaining balance needed for the project, even though it will be able to offset the gap in the running of the institution by private individual contributions.

This project aims to assist 100+ Muslim children from the Mewat district of Haryana who is struggling to make ends meet. The neighbourhood is underdeveloped, and the children's schooling is not very good. Conditions for Muslim youngsters are noticeably worse. The Zamiya Rawzatul Uloom Society strives to enhance the lives of these underprivileged children. We have a plan that will help 100+ Muslim children from low-income families.

They will have access to facilities for clothes and food from us. To help these impoverished children understand their ambitions, we are asking for public donations. These young people attend several madrasas to study Islam.

The education package proposes to fill the gap in what the industry expects and what is presently being produced as a final product in educational institution. In this regard, it will take constant and continual feedback from the industry and provide additional training to the students over and above the established curriculum accordingly. In addition, all students will get minimum access to:

- ✓ To enhance the quality of employable education
- ✓ To search for suitable employment opportunity
- ✓ Holistic development through the formal education
- ✓ To involve students in discussion for improvement
- ✓ Under taking government project for nation building
- ✓ To encourage in income generation programs for women and youths

OBJECTIVES OF THE PROJECT

- ✓ To provide opportunities for free fooding and staying facility including provide free education in four different languages etc.
- ✓ Promoting education and necessary books related to Islamic and modern studies for poor students.
- ✓ Development of the underprivileged Boys children.
- ✓ Encouraging the poor children to go to schools and Madrasa to attain education.
- ✓ Promoting civic sense and sense of responsibility among children.

- ✓ Make the underprivileged children good enough to become good citizens of the country in the future.
- ✓ To impart quality and need based education sensitize the students to their changing roles in society through awareness raising activities.




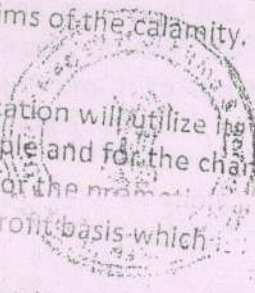

4. Aims and objects of the society :

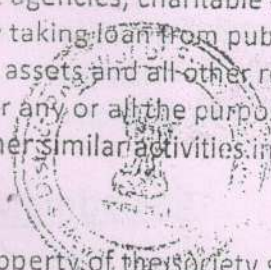

- (h) To open/start educational institutions like schools, colleges, technical and medical institute and to start different coaching centers for competitive exams.
- (i) To start different/open vocational & professional institutes.
- (j) To start computer centers, cyber cafes, NTT centers, different courses of fashion . web designing and other activities to develop personality of young boys and girls.
- (d) Promotion of charity or any philanthropic activity :
- (e) Promotion of arts, education, science, literature, philosophy, religion, industries, skill development, fine arts etc.
- (f) Instruction and diffusion of any useful knowledge :
 - (i) Establishment or maintenance of libraries or reading rooms.
 - (ii) To raise or acquire funds, property, from central Government, State Government, Non- Government agencies, charitable trusts by way of donations or grants or contribution or by taking loan from public and private financial institutions. The funds, properties, assets and all other resources, present and future of the society shall be utilized for any or all the purposes or objects of the society as stated above and also for all other similar activities in furtherance for ideals of truth and non-violence.
- (k) The income and property of the society shall be applied solely towards the promotion of the objects of the society , and no portion there of shall be paid or transferred, directly or indirectly, by way of dividend, bonus, or distribution of any assets, income or profits to its members or profits to its members or their dependents or legal heirs.

3. **Membership of Society :**

- (a) **Eligibility:** A person shall be eligible to become a member of Society, if he:
 - (i) is 21 years of age on the date of admission
 - (ii) Subscribes to the aims and objects of the society.
 - (iii) Has no other membership in any other society.
 - (iv) Is not be an insolvent and of unsound mind or have not been convicted an offence involving moral turpitude, punishable with imprisonment of one year or more.

- (iv) The governing Body may accept or reject the application and the decision of the Governing Body in this regard shall be final. It shall not be bound to assign any reason for its decision.
- (v) The approval the governing body shall be intimated to the member, his name shall be entered in the register of members to be maintained in such manner & form as prescribed under the Haryana Society registration and Regulation Rules 2012.

5. Membership Fee & Annual Subscription :

- (i) Admission fee Rs.50/-
(ii) Annual subscription Rs. 200/-
(iii) The payment of membership fee shall be made by the applicant from his bank account through a Bank Instrument (Demand Draft/Pay Order/Cheque) and in some case it accepted in cash.
(iv) The payment of annual subscription of a member shall become due as on the 1st April of every year, which may be paid latest by the 30th of June of such year. The membership of a defaulting member shall be deemed to be under suspension from the due date (30th June) and such member shall not be entitled to cast his vote during the elections of the society held after 1st July of the said year.

6. Procedure for withdrawal from membership :

If a person willing to be member of the society submit the application in prescribed form alongwith supporting documents to the secretary duly filled in and a signed and recommended by a regular member of the society can withdraw his/her membership application before placing the same in Governing Body.

7. Identity Card for every member:

Every person admitted as a member will be issued an identity card containing his photograph, brief particular and membership category, duly signed by the individual member and the society.

8. Cessation of membership:

(a) Reason for cessation:

- (i) Upon submission and acceptance of his/her resignation ;or
- (ii) If he ceases to fulfil the eligibility condition for being admitted as a member
- (iii) Upon his failure to pay annual subcription fee for a period of that financial year.
- (iv) Upon the death of a member
- (v) Upon his/her acting contrary to the aims and objectives of the society
- (vi) Upon such member being found guilty of a financial misappropriation of the funds of the society.
- (vii) Upon indictment and dirctions for removal by the District Registrar/Registrar registrar General of Societies.

(b) Procedure for Termination from Membership :

If a regular member violate Clause 5 sub clause (i) to (vii)above,a notice will be served by registered post by the secretary regarding the violation of rules. Thus providing him an oportu... in his position personally in the Governing Body meeting and final decision in respect of his membership will be taken by the Governing Body on the basis of the facts given by him and decision of the Governing body will be final. In case Governing Body not satisfied,his membership will be terminated immediately and the decision will be ratified by the General Body later on. After approval of the General body meeting,his name will be struck off from the Register of membership and he will not be entitled to enjoy the rights of the membership.

(9) Re-admission of expelled/suspended members :

The suspension of membership on account of default in payment of the annual subscription may be revoked after he has cleared the default alongwith 18% interest on the amount payable with majority decision of the Governing Body. However he shall not be eligible to cast his vote in any election held during the reminder of the financial year.

However, if District Registrar, Registrar General give dirctions in writing to society for removal of a member, who has been either convicted of an offence amounting to moral turpitude or any misconduct,may be removed from membership.

(10) Right & Duties of members :

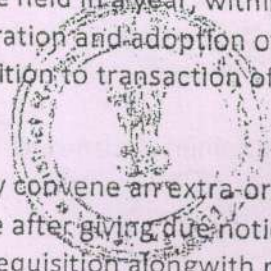
- (i) Every member shall subscribe to and be bound Bye-Laws as amended, from time to time and registered with district registrar.
- (ii) Every member shall have a right to cast his vote at the elections of the society provided such member is not a defaulter in payment of any dues of the society and the annual subscription for a period of three months beyond the due date.
- (iii) Every member of the society shall have the right to inspect the books of accounts, books containing the minutes of proceedings of the general meetings, meetings of the governing body and register of members of the society on any working day by giving a notice of seven days.
- (iv) Every member shall inform the society about any change in his address in writing, which shall be duly recorded in the register of members of the society and upon which the society shall issue a fresh Identity Card to such member.

(11) Composition of General Body :

- (a) Every person admitted as a member shall be a member of the General Body of the society and shall be entitled to cast his/her vote for the election of the Governing Body of the society unless he/she is in arrears of payment of any dues of the society, including the annual subscription.
- (b) Every member shall cast his/her vote in person and no proxy voting shall be allowed.

12. Meeting, Notice and Quorum of the General Body:

- (i) A meeting of the general body of the society will be held as and when required. However, at least one meeting of the general body of the society, called as the Annual General Meeting (AGM) will be held in a year, within six months of the close of the financial year for consideration and adoption of the duly audited annual accounts of the society in addition to transaction of any business of the society as may be required.
- (ii) The governing body of the society may convene an extra-ordinary meeting of the general body of the society at any time after giving due notice, either of its own or within 45 days of receipt of a written requisition along with reason for convening such meeting from atleast five of the members of the general body.
- (iii) For any meeting of the general body, a clear notice of atleast 14 days along with a copy of the agenda of the business to be transacted, date, time & venue of the meeting will be given to the members of the general body. A copy of such notice will also be endorsed to the District Registrar.

(iv) A meeting of the general body may also be convened at a shorter notice, if agreed to, by a majority (at least above 50% of the total members) of the member of the general body.

(v) Quorum for the meeting of the general body will be minimum of four members (if there are maximum ten members in general body). In case of a meeting adjourned for want of quorum, the quorum for the adjourned meeting shall not be less than a minimum of three. The general body shall be competent to transact all business in such adjourned meeting except the consideration of any special Resolution. Any special Resolution can be passed in such adjourned meeting only if at least three-fifth of the total members of the society are present.

(vi) The proceedings of all meeting of the general body will be recorded in the minutes-book (bound or in loose leaves) maintained separately for the purpose by the secretary of the society

13. Powers, Functions & Duties of the General Body :

(i) To guide the society in determining and fulfilling its aims and objects.

(ii) To decide policy matters such as change of name of the society, amendment in the Memorandum of Association and the bye laws of the society, approval of annual account of the society, approval for disposal of immovable assets of the society etc. and all such other acts as may be required under the Haryana Registration and Regulation of Society Act & Rules, 2012.

(iii) To elect the members of the Governing Body

(iv) To remove any member from the continuation of a person appointed as a member of the governing body against a casual vacancy.

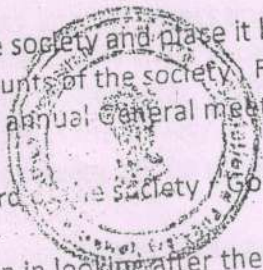

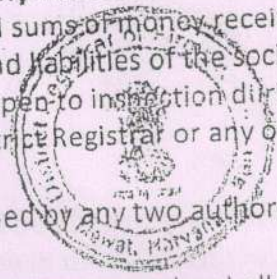

Management of Assets and Fund of the Society :

We invite volunteers, various schools, colleges, communities, corporate governance, and international NGOs

Following are the activities were conducted during the financial year 2020-21:

HEALTH AWARENESS PROGRAM FOR COVID-19:

The society conducted a Health awareness program on covid-19 on 21th of March 2020 at Umra Village of Nuh District of Haryana State. The society decided to go ahead and call for a small gathering while strictly following social distancing at the village PHSC (Physical Health Sub Center). Total numbers of 3 nurses and two Aganwadi staff got together to educate the local members of Zamiya Rawzatul Uloom Society, largely consisting of women about Covid-19 and the significance of personal hygiene.

Thus, the program focused on the importance of washing hands while two nurses volunteered to demonstrate how to wash one's hands properly, Secondly, they focused on the importance of social distancing. The society president distributes masks, soaps, sanitizers to the ones gathered for the day.

FREE MEDICINE DISTRIBUTION CAMP FOR COVID-19:

Zamiya Rawzatul Uloom Society Organized a medicine distribution camp at Nuh District in July 2020, our society distributes medicines to needy and economically weaker people at our locality. We also run health checkup camps to help needy people in 2020-21. We distribute approximately one hundred people in the locality and our motive is to help more people in the future.

EDUCATION PROGRAMME

Our organization's major focus is on improving the educational system, and our Zamiya Rawzatul-Uloom society running a school in Umra village called Flah-E-Insaniyat Public School, where we teach classes I to V and is located on a crossroads linking various areas of the community. As a result, the student will be able to attend school without difficulties. The schoolhouse is a large structure with several components that are still being built. There are several rooms in this school, and presently about more than 600 children read here. The classrooms are large and well-equipped, with all of the necessary

amenities and furnishings, as well as a decent playground. In our school, there are 10 instructors. The supervisor is a wise and experienced guy. The other teachers are likewise well-versed in the subject.

In Umra village, our organization also operates a School for females, which teaches various languages such as Hindi, English, Urdu, and Arabic for a low fee of only 5000 rupees per year. We also want to create a stay-and-learn program for females beginning next year, which will include free meals, free school attendance, and separate female teachers dedicated to girls' contemporary education. Apart from that, the society runs another school for males, which provides free food and accommodation and charges just Rs 2000 per year. In 5 acres, Zamiya Rawzatul-Uloom will be the sole institute for males, particularly orphans. There is no other institute of this sort in Nuh that offers modern education as well as a place to stay. Our main aim is to provide education to every child.

The school & teacher is certainly one of the most important of these influences and it's worthwhile to find out how a school can most effectively carry out this duty.
